Good evening!

Thank you to everyone that has sent in your email address. Per the motion that was passed in June, your information will be extremely helpful in getting information out to the groups more efficiently as we will be able to send documents and other information regarding our Area directly to you. Your information will not be published on the website and will only be accessible to the ASC Admin. If you have not done so already, please send your email address to prchair@sacramentona.org or text to (916) 410-1370.

We have resumed the new GSR Orientation which takes place at 6:30 PM before ASC. The Orientation is available using the same Zoom ID and password as the ASC. If you are a new GSR for any in-person or virtual meetings and have not attended the new GSR Orientation, please join us next month.

We currently have 10 groups facilitating in-person meetings with a total of 15 meetings throughout the week and 50 Zoom meetings listed on the Area website. Once a group has contacted PR that they are ready to resume in-person meetings it will be put on the schedule. Please feel free to reach out to me with any questions you or your group may have regarding re-opening.

For all in-person meetings (new and already occurring), please remember to maintain social distancing and follow cleaning/sanitizing protocols. For meetings located indoors, masks are now required for all participants per the updated Public Health Order. Please help keep our members safe and remind anyone that attends your meeting to wear a facial covering. If you would like additional signage regarding the facial covering requirement for your meeting please contact me and I can send it to you.

I attended the NAWS webinar on July 25th where “NA in the Time of Coronavirus: Next Steps for Meetings” was discussed. Information about re-opening in-person meetings and Hybrid meetings was shared. I have also been attending the weekly Regional PR/H&I sharing forum as well as the bi-monthly Regional PR/H&I forum where issues regarding the Stay at Home Orders, COVID-19, and the impacts on our Areas and meetings are discussed. In last week’s by-monthly meeting, the topic of contact tracing was brought up. It was advised that Areas and groups consider creating a contact tracing plan for any in-person meeting. At this time, it is not a requirement in the Public Health order, however, it was suggested that groups initiate contact tracing as the mandates may change and for the continued safety of our members. For more information about what contact tracing could look like for our NA meetings and what to do if a participant tests positive please contact me.

We are continuing to suspend printing of the schedules and in-person presentations. If you would like to be a member of PR or interested in a service position on the committee, we would be happy to have you! The PR Subcommittee currently meets on the 3rd Thursday of the month at 7:00 PM via Zoom.

I would like to let you know, admin is putting in a motion to start sending the \$50.00 monthly donation to the RSC (region) this is because we have plenty of funds in checking and savings. I wasn't able to get the spread sheet ready in time to get it attached like normal. So here are the figures at this time. Checking \$4,521.71, savings
